FROM I-45 SOUTH

Take I-45 North to Downtown and take the Memorial Drive exit (right-hand lane of I-45). Turn right at the light, which becomes Rusk Street. Continue on Rusk for seven blocks. Turn right on Fannin. 811 Main Visitor Parking will be on your right.

FROM I-45 NORTH

Take I-45 South to the Milam Street exit. Turn left at the light on to Franklin Street. Take Franklin to Fannin Street (3rd signal light) and turn right on to Fannin. Continue down Fannin Street for 6 blocks, then cross Rusk Street. 811 Main Visitor Parking will be on your right.

FROM 59 SOUTH

Take 59 North to the Polk Street exit. Continue down the service road for 6 blocks. Turn left on Capitol Street which is the second light after exiting. FROM I-10 EAST

Take I-10 West to the San Jacinto St/Main St exit. Merge onto Providence Street. Use the left two lanes to torn left onto Jackson St/San Jacinto St. San Jacinto turns right and becomes Fannin Street. Continue on Fannin for eight blocks. Once you pass Rusk Street, 811 Main Visitor Parking will be on your right.

FROM 290 WEST
